- Overweighting a market segment without additional cash

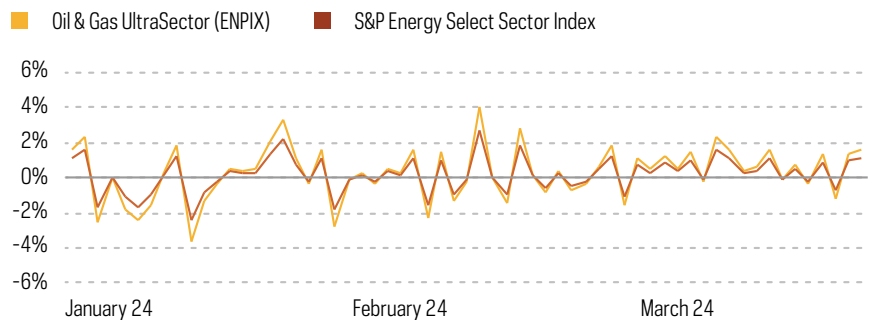

### Daily return during 1Q 2024


